You know Steve Bailey, sure you do.

If you're a member of Sauk Trails Optimist Club, you know him before you see him. When the club met for lunch at the Radisson Hotel before pandemic entered our vocabulary, the mellifluous baritone voice of Steve Bailey could always be heard emanating from the meeting room. Now that we meet via Zoom, "Mister Bailey" is somewhat reduced in the size to that of a postage stamp on our computer screens, but there is nothing reduced about his Optimism.

"People can recognize Optimism in you," says Mister Bailey, a veteran of radio and television broadcasting and an Optimist over thirty years. He has served as President of the Downtown Optimist Club, Lt. Gov. of then Zone 9, District Governor and at the International level on JOI Club committee.

"I can tell you're an Optimist just by listening to you," a pastor once told Steve and so say all of us. The Optimist reputation of Steve Bailey extends throughout the SWIS District whereas Governor Maxine Lane has invoked the Unsung Hero Award to recognize the man behind The Voice:

"He has the ability to share words of wisdom and Christian beliefs with meaning and commitment. He has inspired me and many other Optimists over the years by placing meaning into our lives and our meetings by honoring the Almighty with his powerful invocation full of commitment and purpose."

Sauk Trails President Kathy Newman recently presented Steve with the SWIS District Unsung Hero Award on behalf of current Governor Maxine Lane.



### *Adventures in Optimism*

God Save the Queen.

You realize, of course, the historic figure who shares our daily news, our tempestuous times and respect for tradition, the person who has exemplified both adaptability and dependability through decades unparalleled in the history of the world.

None other than Queen Elizabeth II, a woman who has achieved honor and distinction in her own right, after inheriting a crown in 1952 and pledging herself as Queen of England and monarch of the British Empire in 1953. That's sixty-eight years.

Wife and mother of four, the Queen has reigned through dramatic changes to the United Kingdom, including independence for nations formerly members of the British Commonwealth, involvement of the UK in the European Community and subsequent Brexit. She has visited or been visited by five popes and celebrated so many Jubilees they resemble crown jewels: Silver 1977; Golden 2002; Diamond 2012; Sapphire 2017.

Elizabeth II is the longest lived and longest reigning monarch in British history extending over one thousand years. She is the longest serving female head of state in world history. At age 94 she is the oldest living monarch, longest reigning current monarch and oldest and longest serving head of state in the world.

Indomitable through crisis, Elizabeth II served as a driver and mechanic in World War II, witnessed the bombing of London during the Blitz and burning of Buckingham Palace in 1992, the death of Princess Diana Princess of Wales in 1997 and numerous family tragedies, comedies and sonnets. Every year the Queen delivers her Christmas message and in retrospect, those messages re-echo her first solo radio broadcast in 1940 when at the age of 14, Elizabeth spoke to her own generation on the BBC Children's Hour:

"We are trying to do all we can to help our gallant sailors, soldiers, and airmen, and we are trying, too, to bear our own share of the danger and sadness of war. We know, everyone of us, that in the end all will be well."

God has Saved the Queen.

May He continue to do so.

BOARD OF DIRECTORS MEETING via Zoom

Tuesday, November 10, 2020

MINUTES

**PRESENT:** John, Rick T, Rick C., Kathie N., Kathy J., Bob W., Nancy, Ted, Mary, Ken. **Absent:** Steve

**Welcome** The meeting was called to order at 5:05 p.m.

1. **Approval of 10/13/20 Minutes:** Motion by seconded by Rick T, seconded by Bob W. Passed unanimously.
2. **October Financial Report:** Bob presented the October 2020 financial statements and two proposed operating budgets for 2020-2021 with different sets of assumptions based on the pandemic. John motioned to approve itemized expenses for Foundation including annual report fee, annual raffle license, and \$260 for annual JOI dues which are gifted annually by the Foundation; seconded by Rick C. Passed unanimously. Mary motioned to approve the 2020-2021 operating fund budget based on the assumption of the pandemic lasting for six months resulting in a budgeted net income of \$140, seconded by Rick T. Passed unanimously. Motioned by Kathy J. and seconded by Nancy to accept Bob's financial report for October. Passed unanimously. The Audit Committee reviewing 2019-2020 will consist of Mary B, Dan C, and Carole.  
John motioned to approve itemized expenses for Foundation; seconded by Rick C. Passed unanimously. Mary motioned to approve the 6-month 2021 budget and seconded by Rick T. Motioned by Kathy J. and seconded by Nancy to accept Bob's financial report.
3. **Discussion on Changing the Amount of the Dues:** Bonnie Spindler questioned whether the \$160/year current STOC dues are high that would discourage membership or member retention. She suggested lowering STOC dues to \$30/quarter, especially during COVID. Discussion followed and it was decided to continue to table and review the dues issue.
4. **Fundraising—Bucky Books and Koeze Nuts/Terri Lynn Fundraiser/Silent Auction/Mustard Days/Culver's/and Madison Festivals.** Bob noted that we have one Bucky Book left to sell with all but one of the six free books we earned already sold. Additional books may be purchased on-line with STOC receiving a \$12 profit on each book sold on-line. Rick T. reminded us of Terri Lynn candies available all year; shipping is \$5 per address. Brainstormed on new ideas for fundraisers – need to continue to come up with new fundraisers especially during pandemic. For now, the other fundraisers shown above are not available.
5. **What do we value and enjoy? How do we want to move forward to ensure that we retain and gain new members?** Kathie led a brief discussion on this. It will continue to be on the STOC Board agenda.

MINUTES

- 1. Welcome/Agenda Additions.** The meeting was called to order at 5:05 p.m.
- 2. Approval of 11/10/20 Minutes:** Motion by Steve, seconded by Rick C. Passed unanimously.
- 3. November Financial Report:** JOOI dues to be paid to OI by Foundation, \$260, already approved. Tabled Vanguard Wellington additional investment discussion. One member still owes for one Bucky Book. Motioned by John Fons and seconded by Ken to reimburse Kathie \$158 for Zoom license and Bob \$20 for Annual Report filing fees. Approved unanimously. Bob proposed we amend the budget for 2021 and enter Zoom License expense for \$160 and reduce annual banquet budget to \$330. Kathy J motioned and Mary seconded. Unanimously approved. Audit Committee report: 1) 13 STOC polo shirts in inventory including 7 that people ordered; Bob should bill those people and coordinate delivery. 2) the Committee recommended he put a copy of a check with invoices paid and 3) to avoid sales tax on Amazon, apply for tax-exempt status 4) discussed audit committee recommendations for a credit card. Bob recommends we not open get a STOC credit card now. Motion to accept the Audit Report by Rick C. and seconded by Steve. Approved unanimously.
- 4. Presented Unsung Hero Award to Steve Bailey on behalf of Maxine Lane on Monday, Nov. 30.**
- 5. Discuss Policy changes recommended. Board approval needed.**

Policy Changes:

Sec. 3 under Policies, change Club policies be reviewed by October 31 (change from) "every year" to "even years"

Sec. 7 Dues: (change from) \$16.50 to \$16.75

Homebound seniors shall be charged (change from) \$40 to \$25 per quarter

Sec. 8: Delete pre-billing quarterly billed status

Mary motioned to accept Policy changes as recommended and Steve seconded. Passed unanimously.

- 6. Discuss By-Law change needed for one item to keep it in agreement with the proposed policy change if the Board approves the one item. Members would need to approve a change in the By- Laws.**

Discussed By-Laws will have no changes.

- 7. Fundraising:** Kathy J again made a big sale to Aegis. Last year this sale alone generated over \$800 for STOC. Other nut sales are moving forward. Bucky Books expecting to make \$900; online ordering available til January, and new ideas for fundraising? We are listed as a non-profit on Amazon.Smile.com, so if members choose our Club, we get ½ of 1% toward our Foundation.

- 8. Committees and Activities**

- Ornament Exchange-ideas how to best accomplish this while including everyone. Mary proposed that we each choose an ornament to speak about on Wed., Dec 16.
- Oratorical Contest-Steve Bailey talked about opening our contest to Clubs in the area. We will do this.
- Essay Contest-Mike Grasmick-Kathie will contact him for an update.

- JOOI is holding a Howl-idays Online Concert. They need sponsors and Rick T. motioned and seconded by Rick C. to make a \$100 donation. Passed unanimously.

- 10. Adjourn** motioned by John; seconded by Bob W. Adjourned at 6:04 p.m. Adjourn to January 12, 2021.
