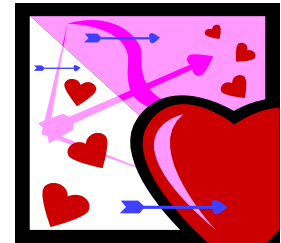

A motion was made, seconded & passed to approve the Treasurer's Report.

A CPA (Community Projects Award) booklet plus an Awards Point Sheet was submitted to the SWIS District for the quarterly awards competition. Board members were reminded of the next District conference on February 8 & 9 at the Country Inn in Waukesha.

Seventeen club members attended 5 or more luncheons during the first quarter.

The next Zone Meeting will be at 6:15 pm on Wednesday, January 16th in Middleton.

A motion was made, seconded & passed to approve the revised club policies and procedures presented by Bonnie.

A motion was made, seconded & passed to have Rick Tiedeman assume the remainder of the Vice-Presidency term of Lisa Schluesche who resigned as an officer due to her employment.

Bonnie will contact members to get a candidate to serve the balance of Rick's one-year board term.

Bonnie indicated that she has sent a letters & checks to both Big Brother/Big Sisters and the Wisconsin Safety Patrol asking them to come to our club and speak about their organizations.

Bonnie indicated that our committees received good feedback on the Power Point presentation at the January 9th luncheon meeting. Those names will be forwarded to each committee.

District Conferences

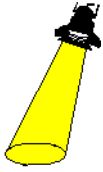

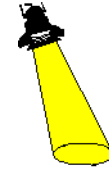

It will be sponsored by the Brookfield Optimist Club and held at Brookfield Central High School gymnasium in Brookfield. The entry fee will be \$15 per participant.
